CERTIFICATE

The Government of Gujarat has No Objection if CRYSTAL INTERNATIONAL SCHOOL, Jam Kandorana Road, Dhoraji, Dist- Rajkot run by SUN GLORY EDUCATION FOUNDATION, Rajlaxmi Park-2, Datarwadi, Dhoraji, Rajkot is being considered for affiliation by the Central Board of Secondary Education (CBSE), New Delhi for Secondary School. Subject to following conditions.

1. A copy of the letter of affiliation shall be sent to the Gujarat Secondary & Higher Secondary Education Board, Gandhinagar as well as the Education Department of the State Government as soon as the School gets affiliation with CBSE. The school shall be required to get itself registered with the Gujarat Secondary & Higher Secondary Education Board, Gandhinagar.
2. The School/Institute shall be open to inspection by the officers of the Education Department or the Officers of the office of the District Education Office, duly authorized in this behalf as per relevant by-laws of the Concerned Board.
3. The School/Institution shall have to obtain necessary permission of the Government of India and other concerned authorities where it is necessary and also shall have to obtain renewal of fire safety certificate from the competent authority.
4. No grants or any financial assistance shall be given by the State Government to the School / Institute.
5. This NOC is valid for six months from the date of issuance.
6. The School/Institution shall produce an undertaking to the effect that it shall follow the provisions of the Gujarat Self-financed Schools (Regulation of Fees) Act, 2017 and the rules made there under.
7. The School shall upload their data to U-DISE System (Unified District Information System for Education) and update it regularly.
8. In case of any breach or contravention of any of the provisions of the Affiliation, bye laws of the respective Board or any provisions of the Gujarat Self-financed Schools (Regulation of Fees) Act-2017, and the rules made there under or any of the conditions of the NOC, State Government reserves its right to withdraw the NOC.




